# REQUEST CONCERNING SURVEY AND APPLICATION PROCEDURES

#### **FOR**

#### FINANCIAL AID FOR SCHOOL EXPENSES

Fussa city provides financial aid for expenses for school supplies, school lunches and other necessities to parents or legal guardians whose children are enrolled in school but who have difficulties paying their school expenses. To those who want to receive this aid and are receiving the livelihood assistance at present, Fussa City requests that they return the Survey and Application Form after filling out. If you have two and more children enrolled at municipal elementary or junior high schools in Fussa City, only the Application Form for the eldest child is requested to fill out. You can only omit to fill out the Application Form for other children but are requested to submit the Survey and Application Form for them too. If you would forget to submit it, you cannot get financial aid for them.

When your children are transferred to a school in Fussa City or the financial condition of your family has changed, you can apply for this program even in the middle of the academic year. You are approved in the month when you apply for it.

Fussa City conducts surveys for this program and all participants are requested to return the Survey and Application Form whether or not they want to receive financial aid.

## **Eligible Families** who live in Fussa City

- (1) Families who are receiving the livelihood assistance at present.
- (2) Families whose livelihood assistance was discontinued or abolished after April 1.2023.
- (3) Families whose resident taxes (city and Tokyo metropolitan) for fiscal 2023 or fiscal 2024 were exempted or reduced.
- (4) Families whose household income in 2023 is below the approved standard.

Other than expenses above, financial aid for school supplies for first graders who will be enrolled in 2025, medical expenses (only for diseases specified in the law.), fee for "The school life guidance & management form" will be paid.

At Fussa City Schools, all school lunch expenses will be covered by public funds starting from 2024, so school lunch expenses will not be paid from tuition assistance funds. Parents of children enrolled in national, public, or private schools other than Fussa City will receive the allowance only if they are responsible for the actual expenses. (It will not be paid if the guardian does not pay.)

To families who are receiving the livelihood, financial aid for school supplies for first graders, school supplies, class materials and medical expenses are going to be provided by the Social Welfare Division.

#### **Deadline and Place to submit**

Please submit the Survey and Application Form to a school your children are enrolled or the School Affairs Desk of Fussa City Board of Education by April 12( Fri), 2024.

#### To parents who wish to receive financial aid

Please fill out the necessary items on the Survey and Application form.

You are required to submit them EVERY YEAR.

### 1. Pay attention to the following matters when filling out the Application Form for financial aid.

- (1) Financial aid for school expenses and subsidy for special support education will be managed by a school principal and a head of a school lunch center and paid through them. Parents don't need to submit a bill to the board of education.
- (2) Fussa City Board of Education peruses the basic register of your resident registration and the basic register of your city and Tokyo metropolitan resident taxes in approving for the aid.
- (3) If you have not yet paid school expenses, the amount in arrears will be paid to the school or the school lunch center directly not to your designated bank account.
- (4) Financial aid for school expenses and subsidy for special support education will be paid to your designated bank account. When deposit is completed, you are considered to receive the subsidy. We don't send a notice.

#### 2. This application form is important to receive financial aid. Please provide factual, correct information.

- (1) Residence and rental fees:
  - Circle the applicable one and write down the amount of your monthly rent.
- (2) Conditions of the household (provide information as of Apr.1, 2024.):
  - Write down all members of the household with whom you share daily expenses.
  - Write down the family relationship within the family from the perspective of the children.
- (3) The name on the bank account is an applicant's only. If the name on the bank account changes in the middle of the school year, please tell the Fussa City Board of Education.
- 3. Please be sure to attach one of the following documents as a certificate of your income. But those who live in Fussa City as of Jan.1, 2024 and report resident taxes do not need to attach the document.
  - (1) Families whose livelihood assistance based on the Livelihood Protection Law was discontinued or abolished in fiscal 2023 or fiscal 2024 ←reasons for application #2:
    - Certificate of discontinuation or abolishment of the livelihood protection welfare program (issued by the local welfare office).
  - (2) Families whose resident taxes (city and Tokyo metropolitan) for fiscal 2023 or fiscal 2024 were exempted or reduced. ← reasons for application #3
    - For families whose resident taxes were exempted or reduced in other city:
    - Certificate of exemption or reduction of your city and Tokyo metropolitan resident taxes for fiscal 2023(issued by a government office registered on Jan.1.2023) or for fiscal 2024 (issued by a government office registered on Jan.1.2024).
  - (3) Families whose household income is qualified as low-income ←reasons for application #4

For families who lived in other city as of Jan.1.2024:

Certificate of your income for 2023(Jan.1.2023~Dec.31.2023) such as a certificate of tax deducted for 2023, a copy of an income tax return for 2023, a copy of resident taxes for 2023, etc.

- 4. Please be sure to attach documents as a certificate of your house rent.
- If you forgot attaching them, your house rent would not be taken into account.
- You cannot submit either transfer statements or receipts as house rent certificates.
- **5. You will be notified around** mid-July. whether approved or not.
